- Court time not paid in full by Sept. 1, 2009 may be resold.
- Unscheduled court closing will be made up at the end of the season.
- Club is not responsible for injuries sustained on its premises or in parking lots, nor for the loss of personal property from the premises.
- Proper tennis shoes are required -No cross trainer or running shoes.
- No cell phones.
